The ESG Pro consultancy team conducted a preliminary audit and discovered many opportunities to score additional points had been missed, that the articles of association had not been modified, and many responses lacked the essential supporting documentation.

U4L filed an audit extension request with B Corp and our team of sustainability lawyers set to work against a most challenging deadline!



Target

To become a certified B Corp!



Time frame

Commencing in November 2023, the challenge was to secure certification within ONE MONTH.

Key tasks

- Audit and improve the Human Resource team's policy library.
- Draft the amended Articles of Association and submit to Companies House.
- To establish supporting documentation in support of the BIA disclosures to raise the company's score to be well in excess of the passing grade for B Corp certification.
