- ✓ **PPN 006 (06/21):** a Carbon Reduction Plan demanded in public procurement. Reports audited by the Cabinet Office. Requires scopes 1, 2, and five categories of scope 3.
- ✓ **SECR:** Managed by the Dept. for Energy Security and Net Zero, audited by the FRC, and demanded by the Companies Act (2006) to be included in annual reports.
- ✓ **ESOS Phase 3 & 4:** Overseen by the UK Environment Agency (EA), with penalties of £500/day for non-compliance. Align to PAS 51215 and engage Lead Assessor.
- ✓ **EPDs & LCAs:** The voluntary reporting of embedded carbon in products. Suppliers in manufacturing supply chains at highest risk. Time consuming and complex.
- ✓ **CBAM:** The EU carbon tax on the import of high-carbon goods. Businesses in-scope require expert guidance as too complex to administer internally.
- ✓ **SBTi:** The Science Based Targets Initiative is a voluntary scheme imposed on many suppliers by various corporations.
- ✓ **ISO 14068:** The standard for declaring Carbon Neutrality. Protects from greenwashing claims.
