- ✓ **Carbon Emissions Reporting:** Scopes 1, 2, and 3 are essential. Must be completed to Cabinet Office PPN 006 standards with a minimum of five scope 3 categories.
- ✓ **Pass Modern Slavery Assessment:** It's not a "tick box" exercise, and challenging for all businesses as policies and procedures must be robust and audit-proof.
- ✓ **Supply Chain Auditing:** Prove your suppliers are ethical and have genuine sustainability metrics. Requires surveying, and precise documentation.
- ✓ **Social Value Reporting:** Now required under the Procurement Act 2023, and it's a challenge for almost every business since software options are expensive.
- ✓ **ESG Rating:** Mandatory for achieving top Evergreen levels with B Corp and EcoVadis certifications preferred. This means establishing all required policies, documenting Corporate Social Responsibility (CSR), and more.
